## President's Report

The last year of the twentieth century saw The Ontario Historical Society continuing to face the challenges of helping to preserve Ontario's heritage, just as it has done since the nineteenth century. It will come as no surprise to our membership to learn that the first year of the twenty-first century is indicating no abatement of those challenges.

The society has become the 911 of the heritage field in the province. Daily the OHS staff receives requests for help and advice from our affiliated members, individuals, organizations and institutions as they, too, are faced with problems and dilemmas. For instance, our resounding victory when challenging the developers over the Clendennen Cemetery has resulted in an increasing number of appeals for assistance in dealing with cemetery problems across Ontario. For this reason the Society is continuing to take donations for the Cemetery Defence Fund.

In the past year, representatives of the OHS have travelled all over Ontario attending meetings, offering advice, support, and practical workshops to our member societies, institutions and interested individuals. It is a policy of the Society that we do not place ourselves at these events but that we respond only to requests for our attendance. Given the thousands of kilometers that have been logged by Dorothy Duncan and her staff, helped out occasionally by members of the Board, one can appreciate the reputation for practical support and advocacy which the OHS has earned.

That reputation has been confirmed in many ways over the years, but in 1999 it was given emphasis when we learned that we had inherited the family homestead of Sir Frederick Banting. Mr. Edward Banting had confidence that we could find a way to preserve the historic features of the farm. We are presently receiving and reviewing suggestions that we have acquired, both as a result of asking for our members' ideas and holding meetings both in Alliston (where the farm is situated) and at our headquarters. We have held, and are continuing to hold such meetings, some with special interest groups. Our goal is to arrive at a feasible plan that will prove both that Mr. Banting's faith in us was not misplaced and that will serve the aims and objectives of the Society.

In this Annual Report you will learn of the work that has been accomplished on your behalf. Little of this would be possible without the following groups. The Board of Directors who have contributed their considered expertise and advice and willingness to take on responsibilities when requested. That dedicated band of volunteers who can be relied upon to be there when needed, whether it be to represent the society at heritage events, to staff sales counters, or to prepare and serve food. Finally Dorothy Duncan and her staff, who have proved their devotion to the cause time and time again by the extra, extra miles that they have been willing to go. My personal thanks go to each of these people.

The year 2000 will, I am sure, continue to provide the trials and the triumphs that The Ontario Historical Society has experienced over the past century. We have come through with many more victories than defeats. Given the strength, efficiency and commitment of the membership to the health of heritage in Ontario, I have no doubt that we will maintain that standing over the next century.

# **Executive Director's Report**

The Ontario Historical Society has now spanned three centuries and its members can look on its accomplishments with pride. As we report on the year 1999 and the early months of 2000, ever conscious of the beginning of the new millennium next year, there are many positive aspects of our work to report.

As our members know, we finally received the decision of the Tribunal who heard the appeal of the OHS and the Ontario Genealogical Society of the closing and moving of the tiny, historic Clendennen Cemetery in Markham. The headline "We Won!" on the front page of the OHS Bulletin proclaimed the relief and the pleasure of all of us, Board members, staff, volunteers, members and donors.

When the OHS was formally created with a Special Act in the legislature of Ontario on April 1, 1899, we were given the very special priviledge of accepting "affiliated" members. This Act is unique, we believe, in all of North America, for, if we accept a "pioneer or historical society" as an affiliated member that organization is immediately incorporated in the Province of Ontario as a non-profit corporation with all the rights and priviledges of the OHS. In these uncertain times, we are continually deluged with requests for affiliation leading to incorporation, with the resulting expansion of the heritage community and our service to it. Not only have we welcomed many new members this year, we have also expanded our circle of partners and dramatically increased our events and programmes.

The following pages will confirm the scope of our work. Your membership fees combined with the continued support of the Ministry of Citizenship, Culture and Recreation made this possible. Well done!

## **Publications**

The Ontario Historical Society publications continue to sell well across Canada with sales doubling in 1999 over the previous year. Three of our popular booklets have been reprinted since January of 1999 Writing History, Deck the Halls, and Serve it Forth! Changes to our Directory of Heritage Organizations and Institutions in Ontario are made on computer as they occur and this will be the basis for reprinting the Directory in the coming months.

Buon appetito! A Symposium on Italian Foodways in Ontario, held November 6 at our headquarters was an unqualified success and the papers presented there will be introduced today, May 6, 2000, in our newest publication *Buon appetito! Italian Foodways in Ontario*, edited by Jo Marie Powers. Professor Powers has also agreed to edit *Tombstone Tales from Ontario's Cemeteries* by Harvey Medland.

The OHS received partial support from Ontario 2000, the Ministry of Citizenship, Culture and Recreation in 1999 for several initiatives celebrating the coming new millennium; one of them a publication based on the **Celebrating One Thousand Years of Ontario's History** symposium held April 14, 15, 16, 2000 in Willowdale. Work will begin on the publication immediately as it must be published before the end of the year, to comply with support criteria.

# Ontario History

Much of my first year as editor of *Ontario History* was spent catching up with the backlog that resulted in part from the change over from a publication schedule of four issues of the journal annually to two issues. Two issues were produced in 1999 (Spring and Autumn) and each was made up of four articles (and lengthy book review sections) which ranged widely in time and subject matter. In the closing months of 1999 much time was devoted also to preparing the special issue for Spring 2000. This issue, guestedited by Dr Dean Jacobs, director of Nin.Da.Waab.Jig/Walpole Island Heritage Centre, is titled "Continuity and the Unbroken Chain: Issues in the Aboriginal History of Ontario" and is the first in the journal's long history to be edited by a Native Canadian.

Through this first year of my editorship I also engaged in discussions with the Society's Board of Directors concerning the layout and format of the journal. The 1999 issues were printed as previous ones had been but the Board agreed to a change in format (to a trim size of six inches by nine inches) beginning with the Spring 2000 issue. This will bring the journal into line with other, similar publications.

The Editorial Advisory Committee for the journal for 1999 was made up of ten members: Linda Ambrose, Nancy Christie, Cynthia Comacchio, Sharon Cook, Donald Graves, Dean Jacobs, Patricia Jasen, Jan Noel, Carmela Patrias, and Randall White. All members are to be thanked for their dedication to the journal and to their work on its behalf. Three members of the committee; Sharon Cook, Dean Jacobs, and Patricia Jasen have completed their terms this year and their replacements will be announced shortly. As in the past, Jim Clemens has continued as the journal's book review editor and I would like to take this opportunity to thank him for his wonderful effort. Like my predecessor, I continue to be amazed by Jim's ability to find readers for the very broad range of volumes that are reviewed in each issue.

## Museums

The Museums Committee of the OHS gained momentum in 1999–2000 as its members collectively worked to bring issues and concerns to the forefront of the political agenda. The committee was comprised of Elmer Pilon, Bytown Museum, Ottawa; Sally Warren, Peterborough Centennial Museum and Archives, Peterborough; Elizabeth Hunter, Brant County Museum, Brantford; Cindy Crawford, St. Joseph Island's Museum; and Sharon Heath-Trottier, Timber Village Museum, Blind River. I want to thank John Carter who worked with the committee and served as a government liaison from the Ministry of Citizenship, Culture and Recreation, and the OHS staff Dorothy Duncan and Lorraine Lowry.

A number of key issues for the committee related to the Ministry of Citizenship, Culture and Recreation's proposed changes to the Community Museum Operating Grant and Regulation 877 R.R.O 1990, governing grants to museums, the review of the *Standards for Community Museums in Ontario* and the development of additional new standards. The revisions and changes to both the granting programme and the standards will have a profound impact on the way in which many museums are operated in the future. We participated in a consultation session with Ministry staff and advocated for further meetings in order to involve additional colleagues from the entire Province in these discussions. We prepared a formal response to the Ministry citing key concerns with the process and proposed changes, and urging for an extension in the development and changes to the *Standards for Community Museums in Ontario*.

Furthermore, the Committee worked to revise and clarify the criteria for the Museum Award of Excellence in Community Programming. Collectively we developed Board approved terms of reference to enable the Museums Committee to advocate in a more formal, consistent and proactive approach to the OHS position on museums in Ontario.

The provision of training seminars and workshops form an important part of the Museums Committee's role. We have been defining topics that reflect both the needs of museum workers and timely topics of interest such as funding authorities, and municipal amalgamation issues.

Finally, the role of the *OHS Bulletin* as a vehicle for disseminating museum information has been strengthened through the development of a strong Museum News page. We anticipate that the enhanced content of the page will be a resource for everyone involved in the diverse field of museum work.

## Preservation

As noted in previous reports, the heart of preservation efforts continues to rest with its staff who provide assistance in response to the large number of calls that the OHS receives each year requesting help. As in the past, some issues were referred to the Preservation Committee for monitoring or action. Where appropriate, the committee provided advice and advocacy when the Society's support was needed.

After the great success of last year's Clendennen Cemetery decision in favour of the OHS position, 1999-2000 was a less happy year, largely because of an ongoing lack of action by government to address the pressing heritage issues in the province and because of the emergence of some distressing trends that have had a negative effect in allowing citizens and their representatives to protect our vulnerable heritage resources.

One major issue of increasing importance is the need to provide assistance in tax and other matters to help foster heritage preservation among private property owners. While there have been positive steps in this direction by some municipalities, such as the City of Toronto, as well as by the federal government, the OHS is concerned over the lack of initiative on the part of the government of Ontario on this subject. This concern is shared broadly within the heritage field, as exemplified, to cite but one example, of a resolution received from the Town of Midland calling upon the OHS to lobby the province 'for financial incentives to assist private property owners to maintain, preserve and enhance heritage properties.'

In addition, efforts by Ontarians to protect their past are hindered significantly by the fact that the badly-outdated Ontario Heritage Act continues in effect when it ought to have been replaced to address the changing needs of the province at this time and in the years to come. Furthermore, downsizing and other such issues have created problems in parts of the municipal sector relating to heritage preservation. In some municipalities, support for Local Architectural Conservation Advisory Committees has been withdrawn, making it difficult, if not impossible for some LACACs to continue functioning. In other municipalities, funding has been withdrawn from local museums, thus casting them adrift with potentially disastrous consequences for the health of the heritage resources in their care.

At this time of distress in preservation, the OHS will continue to fulfill its role in promoting good preservation practices. As a part of its larger programme, the OHS would like to invite its members to nominate particularly active LACACs for its B. Napier Simpson Jr. Award of Merit to honour hard work and celebrate success.

# Membership and Local Societies
