THE ONTARIO HISTORICAL SOCIETY The foremost historical organization in the province. The Ontario Historical Society originally called the Pioneer Association of Ontario, was established on September 4 1888 hargely through the efforts of the Reverend Henry Sodding it initially operated as a federation of local groups and was primarily concerned with the promotion of British-Conadian nationalism through the study of history. Reorganize 1 in 1998 and incorporated with an expanded mandate the following year, the Society became increasingly involved in the movement to preserve archival records and historie sites. It also assumed more scholarly pursuits, including a publication program, in addition to encouraging and co-ordinating the activities of local historical associations and muscums. #### PRESIDENT'S REPORT

I am pleased to report that 2010 was a very busy, prosperous and successful year for The Ontario Historical Society. OHS staff and volunteers were very active and it is clear that on many fronts Ontarians are turning ever-increasingly to their history, heritage and roots.

From a financial point of view, the Society is in a sound position, operating in 2010 within its budget, reporting a modest surplus without debt. That being said, the everincreasing interest in all things historical continues to place greater and greater pressure on the Society's limited resources and personnel.

The Society set a new record for itself in 2010 by incorporating eleven not-for-profit organizations in the Province of Ontario, surpassing the previous record of nine set in 2009. In fact, the OHS has incorporated 33 such organizations since March 2007. For more information, please see page 6.

The OHS spent a considerable amount of effort in 2010 reviewing and updating its new website and membership system. These modern systems give us a greater ability to cost effectively serve our members and offer great opportunities for expanding by placing more member services and more electronic information online. Our hope is that the OHS website will become a major online hub for communication and research.

The Society held its Annual General Meeting in conjunction with its Honours and Awards Ceremony on June 12, 2010. Awards were presented in eleven categories, recognizing organizations, volunteers and authors dedicated to preserving and promoting Ontario's rich history. I was pleased to see

that we had a far greater number of nominations than in previous years – another sign of the growing interest in history and heritage. Thank you to everyone who put forward a nomination and to those involved in their review and evaluation. Congratulations to all of the recipients! OHS produced two issues of *Ontario History* this year, covering a wide range of topics on the province's history. Thank you to Tory Tronrud for his efforts as our editor and to guest editors Michel Beaulieu and James Paxton. A special thanks to Thomas McIlwraith, who has stepped down after five years of volunteer service as *Ontario History*'s book review editor.

In 2010, OHS once again hosted the Reading and Remembrance Programme, with the theme Homeland Stories. This program, aimed at developing educational materials for Remembrance Week, is a growing success. I would like to thank sponsors Ontario Power Generation and Veteran's Affairs Canada. I would also like to thank Angie Littlefield and Mary Cook for their extensive volunteer work which makes the program such a success.

As most are aware, the Society spent considerable effort in support of Bill 149, The Inactive Cemeteries Protection Act, 2009. Unfortunately, this Bill was extinguished when Provincial Parliament was prorogued in March 2010. I would like to thank the thousands of individuals all across the Province who signed the petition. In November 2010, Jim Brownell, MPP (Stormont-Dundas-South Glengarry) re-introduced The Inactive Cemeteries Protection Act,

#### **EXECUTIVE DIRECTOR'S REPORT**

The Ontario Historical Society (OHS) has spanned three centuries and its members can look on its accomplishments in 2010 with pride. The mandate of the OHS can be summarized from the Society's Constitution: "The objects of the Society shall be to unite the various historical societies of the province in one central organization, so as to promote communication, interchange of ideas and cooperation among them; and to encourage the formation of new societies representing localities, ethnic groups and special interests, and to promote and extend their influence."

This past year, the Society celebrated a century plus twenty-two with an unprecedented number of new affiliated societies. Requests for affiliation leading to incorporation steadily continued with the resulting expansion of the heritage community and our service to it.

Not only have we welcomed many new members this year, we have also expanded our circle of partners. The OHS continues to broaden its base across Ontario, attracting members from every part of the province and from every discipline of the heritage field and beyond. The strength of the Society rests on the support and enthusiasm of its membership and we confidently look forward to further expansion and influence of that membership in the coming year.

The reports that follow speak well for the diversity and significance of the work done by the Society, and the programmes designed to serve the needs of all the Peoples of Ontario. The Society's 2010 audited financial statements will also demonstrate in detail that the OHS is in sound financial health,

In November 2010, the OHS held an incorporation meeting for the Irondale Historical Society (IHS), an organization dedicated to preserving, promoting and publishing the history of Irondale. The IHS was incorporated through affiliation with the

managing to eliminate all its debts and continuing to operate with a small fiscal surplus.

It is a pleasure for me to thank our President, Bob Leech and the OHS Board of Directors for the many hours and human resources that they have donated to ensure good governance for the Society.

I want to thank our Treasurer, Naresh Khosla, our accountant Sheila Berzitis, and our auditor, John Bovos, *Akler, Browning, Frimet & Landzberg LLP* for all their financial expertise and support this year. The Society remains committed to fiscal discipline, strict spending controls and prudent financial management.

Special thanks must also go to Tory Tronrud, Editor, and Thomas McIlwraith, Book Review Editor for their capable leadership at the helm of our venerable and scholarly journal *Ontario History*.

The Society deeply appreciates the continued financial support of the Ontario Ministry of Tourism and Culture, our sponsors and donors. When I first started working with the OHS, the Society had eight full-time staff. I cannot thank enough my two colleagues Christina Perfetto and Andrea Izzo for their incredible hard work and dedication in this past year dealing with the demands of rapid growth, increased services, heavier workloads and longer hours. Our summer students Timothy Mikkelsen, Ryan Bradley and Matthew La Rose were outstanding in helping us with our daily challenges last summer.

Finally, I want to thank our volunteers who donated approximately 8,460 hours of time to the Society in support of its activities in 2010. Their contributions were invaluable, the value of your time and skills priceless. Thanks to everyone who made it all happen in 2010. The Society will continue to build upon its tradition of service to the province's heritage community to ensure a future for Ontario's past. It remains a great honour and privilege to work on your behalf.

#### TREASURER'S REPORT

At the end of 2010 The **M**Ontario Historical Society had a positive operating balance. The 2010 audited financial statements show an operating surplus of \$4,474 (2009 - \$548). This was achieved through severe cost controls.

The OHS's Provincial Heritage Organization annual operating grant was reduced to \$242,000 in 1996 and since then, it has not been increased. Unless revenues are generated to hire additional staff, it will remain difficult for the Society to deliver its mandate and carry out its mission, particularly the support required to fulfill its legal obligations regarding its affiliated historical societies, manage the recent and rapid growth in the Society's membership, maintain existing programmes and expand popular new initiatives.

In 2010, the Society did not receive any funding from the federal government through the Social Science and Humanities Research Council for the publication of its scholarly journal Ontario History. Between 2005 and 2008, the federal

government funded the journal \$15,672 annually. Not receiving this funding in 2010 contributed to a deficit of \$23,635 Ontario for History, restricting other programme activities.

#### **OHS AFFILIATED SOCIETIES**

n Act to incorporate The Ontario Historical Society, Assented to 1st April, 1899, the Legislative Assembly of Ontario, authorizes the OHS to incorporate not-forprofit historical organizations as separate legal entities in the Province of Ontario. Citizens dedicated to preserving and promoting some aspect of Ontario's history can apply to incorporate through affiliation with the OHS. Each applicant must satisfy OHS' incorporation criteria, which includes preparing a mission statement; forming a volunteer board of directors; establishing a constitution and by-laws, holding a public meeting and paying an administration fee.

Between 2007 and 2010, the OHS incorporated 33 historical organizations across Ontario – 95% of which are not-for-profit corporations based outside of the City of Toronto and 24% of which serve communities in northern Ontario.

In 2010, the OHS incorporated a record 11 historical organizations in one year. The OHS is proud to welcome the following 11 new affiliated societies, four of which are based in northern Ontario:

The Powassan & Area Historical 2010)Society (February 20, The mission of this historical society is to preserve, protect and promote the history of Powassan and the surrounding area and to support the local museum. Its aims and objectives are to disseminate historical information, to arouse an interest in the past and to encourage the preservation of the built and natural heritage and the cemeteries of Powassan, by publishing or printing material; by holding public meetings, lectures and exhibitions

and by undertaking a variety of information sharing, publicity and public education programs.

Les amis du Musée du Moulin à fleur (incorporated Feb. 20, 2010) The mission of les amis du Musée du Moulin à fleur is to collect, preserve and present the diverse culture of the Sudbury Basin by advising on the development of the Flour Mill Museum and providing recommendations for its capital upgrade and maintenance. This historical organization will advise and assist in the acquisition of individual artifacts within the Museum collection; in the planning, research and installation of exhibitions and in the delivery of special events and activities at the Flour Mill Museum.

Glengarry Fencibles Trust (April 17, 2010) The Trust is the result of a commitment by local citizens in eastern Ontario to conserve and enhance the heritage of the Bishop's National Historic Site at St. Raphael's. Its purpose is to advance education by improving the public's understanding and awareness of the civic and cultural history of this 1786 pioneer settlement which is home to the first Bishop and College of Upper Canada, and to the first Premier of Ontario. Scotland's Glengarry Fencibles are rooted here and were re-mobilized for the War of 1812, accompanied in battle by the distinguished military chaplain Alexander Macdonell (later bishop). The Trust will work to conserve the built and natural assets of this site (1808 house, the college, 1812 military parade ground) by

promoting the civic and military heritage in defending Canada and in forming citizenship and public service.

Soo Pipe Band (June 12, 2010) The Band is located in Sault Ste. Marie and maintains a tradition of outstanding community service and award winning skills dating back to its formation in 1915. The Soo Pipe Band's existence began through the efforts of two Scottish immigrants, Peter Buchan Sr. and John Mudo Nicholson. From that time to the present day, the band has had a rich and colorful past and will continue to promote the region's history and support local museums by providing music and services for public and charitable events.

National Historic Sites Alliance for Ontario (NHSAO) (September 12, 2010) The objectives of NHSAO are to achieve a collective understanding of the meaning of heritage designation and a commitment to achieve and maintain the commemorative integrity of National Historic Sites. NHSAO provides a forum for communication and cooperative action among owners and managers of National Historic Sites and others (government, non-government organizations, foundations, etc.) who have an interest in these sites. NHSAO creates greater public awareness and understanding of heritage conservation and supports National Historic Sites when their commemorative integrity is threatened.

Haliburton County Historical Society (September 12, 2010) The objectives of the Haliburton County Historical Society are to preserve and promote Haliburton County's natural heritage, built structures and cemeteries including archival documents and to advance education by improving the public's understanding and awareness of the county's history by hosting events, displays and producing educational materials.

Friends of Twelve Mile Lake Church (September 12, 2010) The objectives of Friends of Twelve Mile Lake Church are to work with the Township of Minden Hills to preserve and maintain Twelve Mile Lake Church at its original location within Twelve Mile Lake Cemetery as a building of historical significance in the Township and the County of Haliburton; to increase the community's awareness and appreciation of the historical significance of Twelve Mile Lake Church by hosting educational events; and preparing displays and to raise funds through annual fundraising activities that will support the Friends in its efforts to maintain the church building.

North Halton Celtic Historical Society (September 12, 2010) The objectives of the North Halton Celtic Historical Society are to bring together those people interested in the history of settlement in North Halton, in particular to preserve, protect and promote the historical value of the Fallbrook Farm, including the building, nearby bridge and remains of the mill site, and to research and present historical data pertaining to the region.

**Irondale Historical Society** (November 27, 2010) The objectives of the Irondale Historical Society are to promote public interest in the history of the Irondale area; to advance education by improving the public's understanding and awareness of the cultural history of Irondale by hosting events, displays, exhibitions and performances and producing educational material; to encourage the preservation of natural, archaeological and architectural cultural heritage resources in the Irondale area and to work in conjunction with other organizations, having a common interest in the local history of Haliburton County.

Howe Island Historical Society (November 27, 2010) The objectives of the Howe Island Historical Society are to collect, research, preserve and publish material pertaining to the history of Howe Island; to encourage the preservation and protection of buildings and structures of local historical and architectural significance and of unique local natural heritage landscapes and to provide a forum for citizens in order to encourage a greater awareness and appreciation of Howe Island's history.

Friends of the Ermatinger Clergue National Historic Site (FECNHS) (November 27, 2010) FECNHS is a membership based historical organization which promotes the awareness of the Ermatinger Clergue NHS and informs the public of events and available services. FECNHS supports and assists staff in carrying out special events and programs through the acquisition of materials, equipment and the recruitment of volunteers. It also fundraises to meet the Site's operating and project requirements while ensuring the continued preservation of local history.


ntario History, vol. 102, featured eleven articles in two issues. The first began with Andrew Burtch's "True Crime at the Canadian War Museum, 1945-1946," a fascinating account of theft and murder involving one of the nation's national museums, followed by an analysis of Ontario's milk industry in the Great Depressions (by Andrew Ebejer), which showed that consumers with a righteous cause can have an impact on government for the betterment of us all. Ben Robinson's discussion of the evolution of baseball in rural Ontario in the late 19th and early 20th centuries added new insights into the history of the sport, and George Warecki's "Politics and Planning for Atikaki, 1972-1983" added much to the literature on the impact of governmentsponsored conservation on local communities. The issue ended with two articles by Brendan Edwards and Katharine McGowan both dealing with different aspects of the life of Charles A. Cooke, a prominent Mohawk-Ojibwa scholar and influential member of the Department of Indian Affairs in the early years of the 20th century. These were nicely introduced by Timothy Winegard.

The autumn issue of the journal published four articles on the subject of entertainment, agency and power in Upper Canada, reaffirming Ontario History's position as an authoritative voice on the period. Through her study of the games people played in taverns, Julia Roberts showed how entertainment bound people together in a way that help them define themselves. Elizabeth Jane Errington went on to describe how cultured women of the period, who would never be found in a tavern, used entertainment to reinforce their status as gentlewomen of the empire. Michel Beaulieu and James W. Paxton guest edited the issue. Beaulieu's article on entertainment in Kingston, 1816-1837, showed organized entertainments how and private amusements provide a barometer of the social and political atmosphere of the town. And Paxton, in "Merrymaking and Militia Musters," demonstrated how enduring military links from the revolutionary war period, particularly between Mohawks and loyalists, were reinforced by parties, reunions and musters in the 19th century, sometimes to the consternation of colonial authorities.

The two issues presented 19 book reviews, courtesy of the hard work of book review editor, Tom McIlwraith. The range and quality of these books affirms that the publishing of history continues to be strong in Ontario.

Finally, I wish to thank all those who must remain anonymous, namely the scholars who, as peers, contributed freely of their valuable time and expertise to read and comment on the many articles submitted to *Ontario History*. Thanks is also due to Dr. Thomas McIlwraith, *Ontario History*'s Book Review Editor for the past five years, who will be stepping down in 2011. Dr. McIlwraith will be replaced by Dr. Ronald Stagg, Professor of Canadian History at Ryerson University, to whom we extend a warm welcome.

#### **CEMETERY PRESERVATION**

In 2010, the OHS achieved many accomplishments in the struggle to protect, preserve and promote Ontario's cemeteries, thanks in part to an increase in donations from OHS members.

In June 2008, Jim Brownell MPP, (Stormont-Dundas-South Glengarry) contacted the OHS to inquire whether the Society was interested in partnering with him on a Private Member's Bill to protect Ontario's Cemeteries from relocation. The OHS accepted Mr. Brownell's offer. In the summer and fall of 2008, OHS worked closely with Mr. Brownell and his staff and consulted with partners and volunteers in the research and drafting of new legislation.

On February 19, 2009, Jim Brownell tabled Bill 149 - The Inactive Cemeteries

*Protection Act, 2009*, at the Legislative Assembly of Ontario. On March 12, 2009, Mr. Brownell moved Second Reading of Bill 149. After substantial debate with all parties of the Legislature supporting Bill 149, the motion was carried unanimously that Mr. Brownell's legislation be referred to the Standing Committee on General Government.

In April 2010, we informed our membership that *The Inactive Cemeteries Protection Act, 2009* would not be enacted. When the 1st Session of the 39th Legislative Assembly of Ontario was prorogued on March 4, 2010, Bill 149 was extinguished and denied a final vote at Queen's Park.

It came as no surprise to the OHS that a few weeks later it was informed by the descendants of families buried in the Cooley-Hatt Pioneer Cemetery (circa 1786) in Ancaster, that The Ontario Municipal Board (OMB) had ordered a prehearing conference on an appeal by Sulphur Springs Development Corp. concerning a proposed plan of subdivision.

Because the Province in 2006 ruled that the Cooley-Hatt Cemetery was an "unapproved" cemetery, its fate would not be determined under the *public interest* clauses of the *Cemeteries Act*. Therefore, the OHS, for the very first time, was forced to appear before the OMB on a cemetery issue.

On May 11, 2010, at an OMB prehearing in Hamilton, the OHS argued that it was not in the public interest to proceed with a full OMB hearing until the Provincial Government had decided on the relocation of this historic cemetery. The OMB ruled against the OHS and ordered a full hearing. OHS immediately decided not to participate in any OMB hearings and launched a provincial petition opposing the relocation of the Cooley-Hatt Cemetery.

The Cooley-Hatt petition attracted enormous support from thousands of citizens from over 270 cities, towns and villages opposing the desecration of the cemetery. All the petitions were tabulated by the OHS and delivered to the Legislative Assembly. Many MPPs joined Jim Brownell in reading and tabling these petitions during the autumn session.

On November 2, 2010, Jim Brownell, MPP and now Parliamentary Assistant to the Minister of Consumer Affairs (also responsible for Ontario's cemeteries) reintroduced *The Inactive* 





#### **CEMETERY PRESERVATION**

Cemeteries Protection Act, 2010 at the Legislative Assembly. Bill 126 is historic in that it would enshrine in Ontario law prohibition against the relocation of an inactive cemetery. If enacted, it would be in the public interest that our cemeteries remain in their original locations.

The Inactive Cemeteries Protection Act, 2010, would also immediately protect in their original locations the over 1,500 "unapproved" cemeteries in Ontario that are not formally registered. The Legislative Assembly has failed in its duty to properly safeguard these highly vulnerable sacred and historic burial grounds.

The Inactive Cemeteries Protection Act, 2010 would stop expensive, neverending legal struggles and would allow the OHS and its partners to spend their precious volunteer time and donations promoting the restoration of Ontario's cemeteries rather than defending against their potential relocation.

Bill 126 is also a defining moment in the history of this province as it would enshrine for the first time into law that all known inactive cemeteries, whatever your cultural background and faith, are equal, treated with dignity and respect.

This legislation would bring an end to this divisive issue which, over the last sixteen years, has been a costly burden to the taxpayers of this province and a terrible drain on the financial and human resources of the OHS and the OGS.

We can finally report good news on the struggle to save the Cooley-Hatt Cemetery. On January 5, 2011, D.R. Granger, Vice-Chair, Ontario Municipal Board, issued a written decision confirming settlement of this dispute. Vice-"The Granger wrote, Chair agreement reached addresses the conservation/preservation of the cemetery; clarifies the definition of the boundary of the cemetery; and, addresses the process to address gravesites found beyond that boundary.....The applicant confirmed that in their several years of experience, the agreed proposal represents a very positive and an unusually positive outcome in the circumstance."

Because this cemetery is "unapproved", the descendants and the property owner now have to sign a site disposition agreement. Once this is completed, OHS will celebrate with the descendants. The Society would like to thank everyone who signed OHS' provincial petition to protect the Cooley-Hatt Cemetery. Their tremendous support is deeply appreciated.

In 2010, the OHS Bulletin's Cemetery News column remained very popular but the number of articles and pressing issues submitted far exceeded the space available for each publication. Throughout 2010, the OHS helped to research and answer questions and assist families and descendants across Ontario who had relatives buried in pioneer cemeteries threatened by development.

The OHS and the OGS continued their province-wide campaign to determine how many cemeteries are not registered with the Province of Ontario and are therefore highly vulnerable, from a legal standpoint. There has been a long and continuous exchange of information with historical organizations and institutions across Ontario. OHS and OGS volunteers have donated their expertise and countless hours to this historic initiative. They have now recorded approximately 1510 "unapproved" cemeteries in Ontario. The OHS has no appeal rights with regard to these cemeteries and thus it is almost impossible in these cases for the Society to intervene effectively to protect the public interest. In 2010, the Registrar, Ministry of Consumer Services issued Notices of Declaration to declare three burial sites "unapproved" in Prince Edward County, Fort Erie and Mattawa.

In July 2010, the OHS reviewed and provided extensive recommendations to the Registrar's *Policy and Direction for the Restoration* and Ongoing Care of Inactive Heritage/ Historic Cemeteries. With regard to a landfill environmental assessment, the OHS also wrote the Ministry of Environment in support of the protection and preservation of the Martin and Empey Hill Cemetery, designated under Part IV of the Ontario Heritage Act.

In 1995, the Society was forced to establish a trust fund to protect Ontario's cemeteries. The OHS is pleased to report that in 2010 the Cemetery Defence Fund received \$31,476.39 in donations. This included \$25,000.00 from the Estate of the late Dr. Jean Burnet. Our cemetery preservation work depends on financial donations to the Cemetery Defence Fund and on all the time and effort donated by our dedicated volunteers. I would like to thank all of them, in particular Marjorie Stuart, for their invaluable guidance, encouragement and support in 2010.

In 2010, the Museums Committee of The Ontario Historical Society continued to support the museum community through education and promotion, providing letters of support, producing resource material, and networking with smalland medium-sized museums across the province.

This year, the Committee participated in the Ontario Museum Association's OMA at Queen's Park Day. Andrea Izzo, Coordof Comminator unications and Pam Cain, Chair, OHS Museums Committee visited numerous MPPs to discuss the need for continued support of the two core funding programs available to museums and historical societies - Community Operating Museum Grant (CMOG) and Heritage Operating Development Grant (HODG).

The OHS Museums Committee also attended the OMA's Annual

Conference and while there was able to share information with many museums across the province and encourage museum nominations for the OHS Honours and Awards Programme. In 2010, the Honours and Awards Programme honoured the success of three museums in three categories: Lake of the Woods Museum (Museum Award of Excellence), Wellington County Museum and Archives (Russell K. Cooper Award) and the Ontario Jewish Archives (Scadding Award). Congratulations! OHS museum members were busy this year! Of note was the revival of a local museum by the Bruce Mines & District Historical Society (BMDHS). Incorporated through affiliation with the OHS in 2008, the BMDHS initiated discussions with the Town of Bruce Mines to acquire ownership of the local Committee is also pleased to report that after two years of working with the Craigleith Heritage Depot, it has received its operating grant from the Ministry of Tourism and Culture's CMOG program.

## EDUCATIONAL PROGRAMMES, SERVICES AND PUBLIC OUTREACH

#### Incorporation

In 2010, the OHS incorporated 11 not-for-profit corporations through affiliation with the Society. The OHS held 12 incorporation meetings in the following communities: Powassan; Sudbury; Ballinafad; Haliburton; Lancaster; Twelve Mile Lake; Lindsay; Toronto; Howe Island, Waterford and two in Sault Ste. Marie. The OHS also had extensive consultations about the Society's incorporation process with another 8 other historical organizations across Ontario. # Presentations, Outreach and Workshops

In 2010, OHS gave presentations at the Streetsville Historical Society's 40th Anniversary; Mississaugas of the New Credit First Nation; Peel Museum of Ontario's History; Voyageur Heritage Network; The Blue Mountains, Craigleith Heritage Depot; Toronto Branch, OGS; War of 1812 Canadian Heritage Roundtable; Lakefield Historical Tollkeeper's Cottage; Society; Foundation Heritage Canada Leaders' Forum; OMA's Annual Conference and Heritage Roundtable, OMA at Queen's Park Day; Ottawa Women's Canadian Club; and at the OGS' Kingston Branch. OHS was a featured guest on both Green Talk Radio America and on Forum Talk Radio Hamilton.

OHS attended special events at the West Toronto Junction Historical Society; City of Toronto Land Purchase Settlement Celebrations; 50th Anniversary of the North York Historical Society; Lieutenant Governor's Ontario Heritage Awards; the Jack Munroe Historical Society of Elk City at the Prospectors and Developers Association of Canada's International Convention and Trade & Mining Show and Heritage Canada Foundation's 37th Annual Conference in St. John's, Newfoundland.

OHS had a book table and exhibit at The Ontario Black History Society's Annual Brunch in Toronto, Mono's Big Day Celebrations in Mono Centre and Trent-Severn Heritage Network Workshop in Peterborough.

OHS also supported the Mississaugas of the New Credit First Nation's Sacred Tree Project; Heritage Toronto's Willowdale Walk; the 50th Annual Cultural Festival of the Wikwemikong Unceded Indian Reserve and Parkview Neighbourhood Garden's "Container Planting" Workshop.

OHS co-sponsored a 'History of Logging in 19th Century Ontario' workshop in partnership with Marten River Provincial Park and an Accessibility workshop with the Thunder Bay Art Gallery. The OHS, in partnership with the Northern Railroad Museum & Ontario Heritage Centre, Voyageur Heritage Network and the Ministry of Tourism and Culture presented a workshop featuring 'A Guide to Funding Resources for Museums'and 'The History of Capreol'. The OHS, in partnership with the Uxbridge-Scott Historical Society, gave the workshop 'It's Thyme to Learn about Herbs'. In partnership with the Ontario Heritage Fairs Association, the OHS gave a joint workshop 'Beyond the Facts' at The Ontario History and Social Sciences Teachers' Association (OHASSTA) Conference.

#### AGM and Honours and Awards Ceremony

The OHS held a successful 122nd Annual General Meeting and Honours and Awards Ceremony. The keynote address was given by Dr. Dorothy Duncan entitled "From Forests to Farmsteads to Fields to a Neighbourhood Garden: Our ancestors' one mile diet". A reception courtesy of Dr. Duncan featuring simple, healthy and historical fare of our ancestors was held at the John McKenzie House.

#### Insurance Programme

The OHS insurance programme remains popular and the Society continues to process insurance applications on a regular basis. Any historical organization in Ontario that is a non-profit corporation and a member of the OHS "in good standing" is eligible to apply for General Liability Insurance and/ or Directors and Officers Liability Insurance.

As soon as the OHS approves an application for the Insurance Programme, John Thomas, our Insurance Broker, JONES DESLAURIERS, consults each historical organization to ensure that insurance policies are tailored to address specific needs and local circumstances.

As of December 31, 2010, there are 48 historical organizations that have Directors and Officers Liability Insurance policies underwritten at a limit of \$2 million each. There are 47 organizations that have General Liability Insurance policies with liability limits of at least \$2 million and 20 have purchased coverage for contents and property.

There is presently for Directors and Officers Liability Insurance a \$450 flat rate with \$2 million limits and for General Liability with \$2 million limits a rate of \$450 to \$725 (based on gross revenue). For General Liability Insurance, organizations can get quotes for \$1 million to \$5 million limits. Competitive rates for buildings/contents/collections are also now available.

There are many active applications and therefore, insurance policies for our members are underwritten and issued on an ongoing basis.

The OHS insurance programme enables and protects volunteers across Ontario who donate their time and skills to serve on the Boards of Directors of our member organizations.

#### Accessibility

The OHS' Accessible Heritage Tool Kit remained popular in 2010. The OHS gave its presentation 'Making Ontario's Heritage Accessible for People with Disabilities' at the County of Essex's 8th Annual Accessibility Workshop – Open Doors and Minds.

On June 15, 2010, the OHS, at the invitation of the Accessibility

Directorate of Ontario's Outreach and Compliance Branch, attended 'Customer Service Standard Forum the Nonfor Profit Sector' at the CNIB Centre. On September 15th, the OHS was again invited as an Partner with Ontario to participate in 'Partnership Day' at the Royal Ontario Museum. This gave the OHS the opportunity to share its experiences with new EnAbling Change Partners.

Closer to home OHS summer students participated in and successfully completed an accessible customer service training program. This has helped to shape our customer service guidelines and these have been taken into account in the recent redesign of our website.

John Rae, First Vice President of The Alliance for the Equality of Blind Canadians and an OHS workshop speaker and volunteer gave, on behalf of the Society, accessibility presentations in Burlington and Toronto and a workshop in Thunder Bay. John also contributed another feature article, his third in the series, in December 2010's OHS Bulletin, 'Access Beyond the Ramp – Part 3: Making Collections Come Alive for Patrons Who are Blind'.

#### John McKenzie House and Parkview Neighbourhood Garden

On February 15th the OHS held a Heritage and Family Day reception for the Society's members, donors, volunteers and friends. The OHS participated in the 11th Annual 2010 Doors Open Toronto. Both days were constantly busy with over 900 guests visiting the historic John McKenzie House in Willowdale. This successful event depended on dedicated OHS volunteers who donated their time to provide tours.

On November 7th, the OHS, in partnership with Dundurn Press, held a special event to launch Dorothy Duncan's most recent book Feasting and Fasting: Canada's Heritage Celebrations and to celebrate Barbara Wall La Rocque's Wolfe Island: A Legacy in Stone. In December, the Society held its annual Women's Canadian Historical Society luncheon. In 2010, the OHS had 5 Board of Directors meetings, hosted 11 community meetings, held 7 special events and had 21 private rentals at the John McKenzie House.

The OHS enjoyed a second-year partnership with the Parkview Neighbourhood Garden (PNG) and looks forward to another successful season of operation in 2011.

The PNG is a communal, organic market garden in Willowdale run by a volunteer steering committee. It is believed to be the first instance in

Toronto of housing being reclaimed for local 'farming'. The garden sits on the site of the John McKenzie property's former vegetable patch adjacent to a milk-house and stable, the latter being used to store tools, equipment, seeds etc. for use in the garden. The first season was a great success, ending with adequate funds to purchase seedlings and supplies for the 2010 gardening season, at the end of which PNG was able to donate a portion of its funds to a local food bank.

In preparation for 2010 a large composter was constructed enabling the team to increase the recycling of garden waste and autumn leaves. There was an ambitious expansion plan for this community garden and an increased volunteer recruitment drive. For example, the North York Garden Club agreed to use its know-how to landscape the entrance to the garden with plantings helpful to bees, butterflies and birds - ultimately benefitting produce growth. The size of the garden doubled with a greater variety of produce which was sold between June and September 2010. In the summer the John McKenzie House continued to host steering committee meetings.

In the autumn, the eavetroughs on the Coach House were replaced and upgraded to improve the collection of clean rain water that flows to an underground cistern from which the volunteers can get water from a traditional farm pump.


Thanks are also due to the North York Community House HOST Program for referring many wonderful volunteers to the garden project. The OHS again had a successful partnership with the HOST Program in providing English as a second language instruction to their volunteers. The garden's success in bringing together neighbours and reviving local heritage highlights the important role of the OHS in the local community, in addition to other communities across Ontario.

#### **Reading and Remembrance**

2010, the Reading and In Remembrance Programme continued to grow, reaching well over 100,000 students with the annual theme of 'Homeland Stories', featuring ten bilingual lesson plans dealing with issues that faced Canadians at home during the war efforts. This programme continues to be a huge success in its ability to reach out to youth and encourage literacy through education about Ontario and Canada's history. Many thanks to Program Managers Angie Littlefield and Mary Cook who work almost entirely on a volunteer basis to produce these free online materials.

#### **Youth Initiatives**

The OHS was proud to be involved once again in the 2010 Ontario Regional Heritage Fairs. The OHS provided ribbons of excellence, certificates and book awards to students at 19 regional youth fairs including Aurora; Durham; Grand Erie; Grey County; Hamilton-Keewatin-Patricia; Wentworth; Kingston; Niagara Catholic; Niagara Public; North Bay; Ottawa; Peel; Perth; Simcoe County; Sudbury; Toronto East; Thames Valley; Toronto West and Trillium Lakelands. This important educational youth initiative is organized by The Ontario Heritage Fairs Association which incorporated through affiliation with the OHS on March



24, 2007. In late 2010, the OHS also established a second Youth Ontario Heritage Fairs Award, the OHS Reading and Remembrance Award, which will recognize Remembrance and War-effort related student projects in future Regional Fairs.

OHS donated a set of the special Ontario History issue 'Consequences of Rebellious Acts: The 1837 & 1838 Rebellions' to the Grade 12 Canadian and World Studies class at St. Theresa CSS, Belleville.

#### Conclusion

the OHS Throughout 2010 provided consultations to over 45 member organizations in order to discuss strategic directions, help solve problems, provide a reference for grant applications, explore heritage designations and easements, review their constitution and by-laws or support their efforts to obtain charitable tax status. They also provided countless heritage consultations over the telephone and e-mail to members of the general public.
